1. Resolved that the Club shall be called the Botany Harrier Club, moved by J. Madden, seconded by J. Wright.
2. Moved by Mr Humphreys seconded by Mr Rowe that this club shall be affiliated with the NSW A.A.
3. Moved by Mr Madden sec by Mr Wright that the entrance fee shall be 2/6
4. That the colours (sic) of the club shall be white with black braids
5. That the officers of this club shall consist of a patron president (and) unlimited numbers (?) Second by Mr Madden, proposed Mr Saissall.
6. Any member of the committee who shall absent (?) himself 3 – Moved by Mr Wright and seconds by Mr Apps

Moved by Mr Wright seconded Mr Humphreys that the first general meeting of the Botany Harriers shall be held in the South Botany town hall on Thursday 18th July at 8 pm.

Moved by Mr Weyman seconded by Mr Wright that Mr Heyman be asked to wait on the Mayor asking him to preside at their meeting and to arrange for the hall

Moved that a vote of thanks be tendered to Mr Hammond for the use of the room for the meeting, carried by acclamation

Moved by that a hearty vote of thanks be tendered to Mr Heyman for presiding, carried by acclamation.

Rules of Botany Harriers

Name

1. That the Club shall be called the Botany Harriers.

Officers

2. That the Office Bearers shall be elected annually (?) and shall consist of a Patron President, Vice President, Hon Treasurer, Hon Secretary, Captain, Vice Captain, Hon Handicappers (3) Auditors (2). Committee of seven (7) with power to add.

Entrance Fee

3. That the entrance fee shall be Two shillings & Six pence for annum, the year of subscriptions to be from one Annual General Meeting to another.

Colors

4. That the colors of the Club shall be navy blue singlets and white trousers.

Affiliations

5. That the Club shall affiliate with the N.S.W. Amateur Athletic Association.

Committee

6. Any member of the Committee who absents himself from three consecutive meetings without reasonable cause shall be deemed to have forfeited his position and the Committee shall be empowered to elect another member in his stead.

Quorum

7. Five (three?) members shall form a Quorum at all Committee meetings.

Annual General Meeting

8. The Annual General Meeting shall be called by the Committee and notice shall be given to all members of the Club.

Accounts

9. The Accounts of the Club shall be audited prior to the Annual General Meeting and an audited Balance Sheet shall be ? by the Hon Treasurer

Headquarters

10. The Head Quarters of the Club shall be at Sir Joseph Banks Running Grounds, Botany and the nights of training shall be ?

Minutes of General Meeting held on South Botany Town Hall on Thursday 17th July there being a muster 35 members of the newly formed Botany Harriers.

Moved by Mr J. Rowe that the Mayor of Botany (Ald C. F. Edheredron) be voted to the Chair (carried by acclamation. The Chairman thanked the members for the honour conferred on him and briefly explained the objects of the meeting. The sub committee's report re rules were read on rule (3) an amendment was moved that seven (7) shall form a committee carried. On rule (4) the colours were left in the hands of the secretary to furnish particulars. The colour (sic) adopted being blue singlets with white trousers. Rule of an amendment moved that (5) members shall form a quorum carried. Moved by Mr Lacey seconded by Mr Rowe that the rules be adopted (carried).

The Election of Office Bearers for the Season 1907 – 8 was then proceeded with the following gentlemen being elected. The patron, Mr Gearin returned thanks and assured the members that he would do all in his power to help the new club along and kindly donated a medal valued at a guinea £1 – 0 – for a race in the season. The Chairman, Ald C. F Edheredron briefly thanked the members for electing him president and hoped to see the club in the front ranks of running. He would donate a medal valued at a guinea £1 – 0 – race through the season. Both gentlemen were thanked for their donation by the members present.

Election of officers being over the member adjourned to general business. Mr Siddons offered his room for the members to go into training till they had secured a permanent room. Moved and seconded that the offer be accepted with thanks.

A deputation consisting of the Chairman Mr Gearin and Mr Weyman were appointed to wait on the trustee of Sir Joseph Banks ground to arrange the lease of grounds and fix a night for the purpose of training. The secretary notified the meeting that he had a sum of £2-2-6 paid into the Club's credit on the night enough to pay the Clubs (sic) affiliation to the N.S.W. A.A.A¹ and leaving a balance of sixpence. Mr L. Devitt read an account of the officers dutys (sic) in their respective work and a vote of thanks was accorded to him. Moved by Mr and seconded by Mr Fazackerley that a hearty vote of thanks be tendered the visitors for their presence at the meeting (carried by acclamation).

Responded to by Mr Gearin and Mr Callinan who both wished the club every prosperity in their new and welcome sport in Botany. A hearty vote of thanks to the chairman who responded closed a most successful meeting. A motion that the meeting adjourn for ? was carried closing at 10.30 pm.

Mr Fazackerley seconded by Mr Humphreys moved that the Club hold a Road Race on Saturday the 10th of August next, carried.

Moved by Mr L. David that the Road Race be from Thorntons Hotel to the Sir Joseph Banks Hotel and finish at Sir Joseph Banks Hotel seconded by Mr Lee.

Mr Fazackerley moved an amendment that a Road Race be held from Thorntons Hotel to the Town Hall at Botany and back to Thorntons. Seconded by Mr Humphreys.

The amendment on being ut was carried. The voting being 9 for and 5 against.

Mr Fazackerley moved that the price for entrance to Race be seconded by Mr Flynn and carried unanimously.

Mr Fazackerley moved that the members be handicapped and then if they are satisfied with the Handicaps they can pay the entrance fee, seconded by Mr L. Devitt and carried. Also no member can run unless the entrance fee is paid.

Mr Fazackerley moved that the Mayor's Trophy of £1/11 be the medal for first home and a trophy valued at 10/6 for second to be taken and of the entrance fee, seconded by Mr Flynn and carried unanimously. Confirmed. CHAIRMAN

(Continued) Mr Tuck moved that a vote of thanks be accorded to Mr Flynn for his kindness in presenting the **dodgers?** for the Club races. Carried by acclamation.

Mr Fazackerley moved that the members of the Club who win medals engrave the medals themselves seconded by Mr Flynn.

Minutes of the Botany Harriers held in Mr Siddons hall, Mr O.W Neilson in the Chair

Moved and seconded that the minutes of the previous meeting as read be confirmed carried.

Moved by Mr Devitt seconded by Mr Tuck that the mile run be held on the 31st

Moved by Mr Fazackerley that the cross country team be taken over a practice run on the 31st carried

Mr Siddons moved an amendment that the Club hold a race on that day - there being no seconder, the motion lapsed. The president sent a letter of apology for his absence and Mr Page. Mr Siddons move and Mr ? seconded that Mr Barlow's offer of a room be declined (carried). Moved by Mr Rowe seconded by Mr Faisell ? that the club enter a team for C.G.G carried. Moved by Mr Devitt seconded by Mr Faisell ? that the drag be engaged for the G.G.G – the cost not to exceed. Mr Faisell moved seconded by Mr Cecil that the club enter a team for the Sydney's ten mile road race (carried). Moved by Mr Fazackerley that the club hold a (2) mile open track race on 21st September first prize £2-2 – gold medal second prize £1 – 1. Also a half mile club race for 10/6 entry fee 1/- admission to grounds (3rd) seconded by Mr Lacey. As an amendment by Mr Faisell that the race be an open road race of 3 mile seconded by Mr Siddons. Motion carried by 10 to (3) . ? to close on the 14th September. Moved by Mr Faisell that entries (?) for the mile club race close on Saturday 23rd seconded by Mr How (carried). Mr Devitt moved that Mr Chapple be appointed a handicapper for the club's race, no seconder – the motion lapsed. Moved by Mr Siddons that a hearty vote of thanks be ? to H. D. Neilson for presiding at the meeting, carried by acclamation. The chairman briefly thanked the members for the vote.

Adopted 9th 9 07.

A committee meeting held at the Club's headquarters Sir Joseph Banks ground on the 9th September. Mr Fazackerley in the chair.

Moved by Mr Fazackerley seconded by Mr Howe that the club hold a road race on Saturday the 11th for the Hamilton Trophy (carried). Moved by Mr Chapple seconded by Mr Faisell that the course be from Hamilton's hotel to Hastings Road and back a distance of a mile and $\frac{3}{4}$ (carried). An amendment moved that the course be from Hamiltons to the grounds (Sir Josephs) and back was lost.

It was decided to charge sixpence for entry fee all over 10/6 to go to the funds for the club. Moved by Mr Fazackerley seconded by Mr Rowe that no member shall finish at the winning post who has not rounded the turning point stewards (carried). Mr Chapple moved seconded by Mr Heyman that infringements of that rule will be liable to a fine of 1/- (carried). Handicaps to close with Mr Siddons on Thursday night. Moved and seconded that the committee be increased by one Mr Pierce being elected to the position. Accounts amounting to 8/- were passed for payment. The meeting closed at 9.45 pm.

The minutes of the previous meeting after some discussion was confirmed.

Letters were received from Mr Callinan and Mr Lacey M.L.A. Moved by Mr Flynn seconded by Mr Faisell that the Hamilton trophy be run for next Saturday. Moved by Mr Faisel seconded by Mr Chapple that the course be from Hamiltons Hotel to Hastings RD ? and back and the time of start be a quarter past three. An amendment by Mr Siddons seconded by Mr Chambers that the race start at three (carried). Turning point Mr and Mrs Rowe and Siddons timekeeper. Mr Gearin referee, Mr Hamilton. Road stewards Botany Bicycle Club. Moved by Mr Siddons seconded by Mr Faisell that entries close on Friday night at 9 pm. Amendment moved by Mr Chapple seconded by Mr Fazackerley that Thursday night be the closing night for hdcps (carried). That the secretary be ordered to purchase nomination forms to the amount of (1000)? Moved by Mr Siddons that a committee be held on every Thursday night in the month. An amendment by Mr Faisell seconded by Mr Rowe that every first and third Thursday in the month was carried. A general meeting was decided on for Tuesday 24th for general business. There being no other business the meeting was closed at 9.50 pm.

The minutes of the previous meeting were read and confirmed. Correspondence was received from Messrs Darcy Leigh and Northcote and read to the meeting.

Re St George Harriers inter Club challenged it was moved by Mr Weyman seconded by Mr Siddons that the challenge be accepted and the date be fixed for the 26th October (carried).

An amendment by Mr L. Devitt seconded by Mr Faisell that the Club hold a sports meeting on the 26th October was lost on the vote.

Moved by Mr Siddons seconded by Mr Gearin that the challenge arrangements be left in the hand of the secretary to report to the Committee (carried).

Moved by Mr Weyman seconded by Mr Faisell that the Club hold a 100 yards hdcp race on Saturday the 5th October for Mr Gearin's trophy.

An amendment by Mr Devitt seconded by Mr Flynn that the race be held on the 13th was carried.

Moved by Mr Tuck seconded by Mr Heyman that all club entries close with the Mr Siddons and Callinan was carried.

Moved by Mr Faisell seconded by Mr Siddons that Mr Gearin be elected to position of chairman of committee. There being no opposition Mr Gearin was elected and briefly thanked the members for the honour conferred upon him.

There being no other business it was moved and seconded that a hearty vote of thanks be given to the president for his kindness in printing which was carried by acclamation. The Chairman briefly ventured (?) thanks and hope to see the members working together with the one accord and that was to push the club along and make a club which will bear credit to the district.

The meeting closed at 10.15 pm.

Moved by Mr Flynn seconded by Mr Pierce that third prize be 7/6 carried. Mr Siddons moved and Mr Flynn seconded that a silver coin be charged for admittance (carried). The matter of the date being secured was left in the hands of Mr Devitt.

The Chairman, secretary, treasurer and Mr Faisell were left with arrangements to secure the Sir Joseph Banks running ground for the 26th.

Accounts amounting to 3/- on the motion of Mr Devitt seconded by Mr Siddons was passed for payment.

Mr Callinan was elected in the position of timekeeper to the club races.

The meeting adjourned till next Thursday night at Siddons hall.

The times of starting races were settled by the meeting and Messr ? and Faisell volunteered (sic) to mark our the courses for 100 yards, ½ mile and two mile trace race. Mr Bullock donated a £1-1- towards the Club's funds. The vote of thanks was passed to him for the kindness.
